Important information for the transport and handling of your exhibits

Transport by Handcarry

Temporary Inbound for the time of the show:

- Brink's Munich staff will assist you on your way through German Customs.
- Meeting point for import clearance of handcarry is the baggage claim behind the inbound passport control. The Brink's employee will have a sign in his hand, showing your name.

Pre-Advice for clearance of handcarry must be send to Brink's Munich at least 2 days before arrival either by fax or by Email.

The Pre-Advice must contain:

- Proforma invoice with invoice date and number, separate prices and terms of delivery
- Number of pieces (cartons) and weight (net weight and gross weight)
- Flight Number / Arrival date and time
- Name of Passenger
- Copy of passport
- Mobile phone no.

!!! Latest arrival date for hand carry is October 21st until 8:00 am!!!

Very Important!!!

The arrival flight for hand carry shipments to Munich must be a **non** EC flight. This means that the first point of entry into the European Community (EC) for the travelling person must be Munich. Therefore, we recommend to use direct flights from your country to MUC or transit points out of the EC (e.g. via UAE or Switzerland) Otherwise, you must declare your goods at the first point of entry into the EC by yourself. No support by Brink's possible.

Brink's Munich employee will go together with you to the German customs office for clearance of your exhibits.

After clearance Brink's Munich will store your exhibits in the airport vault until the delivery to your booth at The Munich Show.

IMPORTANT

Items sold during the show must be mentioned on a separate list showing:

- Description of each item.
- Value of each item.
- Total value of sold items.
- Customs tariff number.

Exhibitors must pay 19% VAT plus 2,5% duties (for jewellery) to German customs for each sold item. Customs clearance can be done only on Monday, 28th October at the local Customs Office at fairground. Duties and Taxes must be paid immediately in cash to German customs. Brink's employee will assist you on your way to the customs.

Return Transport

The time of collection from the booth and the meeting point at the airport for outbound customs clearance will be agreed with the exhibitors during the fair.

Departure flight shouldn't be before October 28th as the Closing of the TIB Clearance can only take place same day in the morning!
